CLAIM AND SPREAD CIVIC POWER

Our democracy is not a business. It is not transactional. It is built on mutual trust and action that require much more than our narrow self-interests.



FOCUS YOUR TIME, TALENT, AND TREASURE

Find organizations and movements that provide opportunities for people to do things together that we could not do alone.



RAISE ALL VOICES

Amplify and share the stories of others, particularly those of us who have been historically silenced. Read, share, and champion them.



ENVISION A MORE PERFECT UNION

Keep picturing what's possible. If you can imagine what a safe, prosperous, and healthy America for all looks like, then it is achievable.



SPREAD THE FAITH

Democracy only works if we believe in it. If we lose faith in that notion and succumb to the cynicism of bad-faith actors, our institutions and systems disintegrate.



BE PATRIOTIC

Loving our country requires perseverance and devotion to our founding creed of liberty and equality. Our country: When right, to be kept right; when wrong, to be put right.

SHOW UP

Ask yourself what you are prepared to do, out in the open, to defend and protect democratic ideals. Be present for our democracy when called.

FIGHT FOR VOTING RIGHTS

Without the vote, there is no method to hold our leaders accountable and no way for our values and vision to be represented. This right is never guaranteed, so it must be defended to the fullest.

BALANCE HOPE AND CONVICTION

Reaching a shared vision will take time, toil, and effort. Together, little by little and step by step, these forces of progress move us all toward a better place.

VOTING RIGHTS INITIATIVES AND PUBLIC POLICY IN 2023-24

HIGH FIDELITY



A familiar sight: Our team helping register new Nebraska voters and emphasizing the importance of voting.

As voters, we are vested with awesome power. But if we don't use it, we lose it. The right to vote is never guaranteed, which is why Civic Nebraska amplifies, champions, and relentlessly defends it. Our Voting Rights Initiatives team is in the streets, neighborhoods, and the halls of power to grow the electorate, support pro-voter policies, and protect ballot access for every Nebraskan.

In 2023, those efforts included:

Following November 2022's mandate directing the Nebraska Legislature to impose new identification requirements on all voters, Civic Nebraska got to work to ensure no one was disenfranchised. The result was LB514, far and away the most accommodating of the proposals offered by state senators. In 2024, Civic Nebraska will focus on educating voters about the new law's effects.

We brought national voting-rights leader Desmond Meade to Nebraska to advocate for LB20, a bill to end our state's arbitrary two-year waiting period for those formerly convicted of a felony to vote. LB20 easily moved out of committee to the statehouse floor, where it will be considered in 2024. We're committed to getting LB20 across the finish line and signed into law.

Our nonpartisan voting-rights advocates canvassed Lincoln leading up to the city's municipal and mayoral elections, providing voters information about registering as well as the various methods of casting a ballot. All told, the team made nearly 5,000 phone calls, knocked almost 1,000 doors, and sent more than 21,000 texts.

Voting is not just a solitary act. It's a collective affirmation of our rights and responsibilities. And when we all participate, voting reaches well beyond Election Day by fortifying to the foundations of our democracy. Every day and in every way, our voting rights initiatives ensure that this foundation is solid for generations to come.

Civic Nebraska has long opposed bringing voter ID requirements to Nebraska. But when voters approved a ballot measure making it inevitable that the Legislature would enact voter ID in 2023, Civic Nebraska led a pro-voter coalition that worked with the Government Committee and election officials to ensure that any new law would be as inclusive as possible.

As a result, the new law accepts a broad array of IDs;

provides state IDs free of charge; and protects voteby-mail; and includes a \$1 million public awareness campaign. Civic Nebraska organizers are already in the field conducting extensive voter education work to prepare for 2024, the first election to be administered under the new requirements.

CIVIC HEALTH PROGRAMS IN 2023-24 **NETWORKING**



Democracy is a prosocial affair. Civic Nebraska empowers citizens to connect, collaborate, and build together.

Civic health is a community's level of civic engagement, participation, and collaboration. We strengthen our civic life – and our democratic way of life – when we all get involved in making decisions, holding leaders accountable, and working together to tackle shared challenges. In other words: We all do better when we all do better.

Activating for stronger civic health begins with being heard, understood, and valued. This is a central tenet of Civic Nebraska's Civic Health Program: We form connections, host space, and identify assets – and by doing so, we tap into new power within our communities.

In the past year, we've fortified Nebraska's civic fabric with:

Civil discourse and media literacy. Our Civic Health Program spearheaded *Crossing Divides*, a statewide effort of a national project to examine root concerns on distrust of institutions and sources of information. The one-on-one interviews with Nebraskans saw new strategies emerge, as well as support for initiatives to heal conflict and make meaningful, positive change. Meanwhile, our team regularly worked with the Osher Lifelong Learning Institute at the University of Nebraska to host civil discourse courses for members, and held screenings of the short film PURPLE to bridge Nebraskans' ideological gaps.

■ Lifting up neighborhoods. Collective Impact Lincoln – a partnership with Nebraska Appleseed that strengthens the capital city's core neighborhoods – took its advocacy work to the next level, launching a housing affordability campaign to rein in source-of-income discrimination. This ongoing campaign, known as *Turned Away*, aims to protect working families and renters while bringing the Star City a step closer to true housing equity.

Rural initiatives. From Scottsbluff to Falls City, from South Sioux City to McCook, Civic Nebraska evaluated, trained, and promoted relationship-building within our state's communities to enhance social capital and trust, and brought diverse groups together to address local, regional, and statewide challenges.

Civic health creates strong communities. That's why we bring Nebraskans together to foster a culture of engagement, participation, and collective responsibility.

In 2022, statewide voter turnout was about 55 percent. With Civic Nebraska's interactive TROVE platform, it's possible to see where turnout was nearly 75 percent and where it was below 30 percent – and begin to answer the question: Why the difference?

Nebraskans can delve into voter participation rates for their city, town, or neighborhood with TROVE. Our interactive Tool to Reflect Overall Voter Engagement shows voter turnout from the November 2022 general election down to the ZIP Code and neighborhood levels. In addition, TROVE compares voter participation against demographic characteristics of census tracts to analyze which may correlate to higher or lower voter turnout.

You can choose any of three ways to view Nebraska's 2022 voter turnout. It's broken down by census tract, ZIP code, or county. You also can enter an address to examine turnout exactly where you, or others, live. TROVE also tracks economic and social demographic

data like median income, poverty, and race.

YOUTH CIVIC LEADERSHIP IN 2023-24 **TUNED IN**



Our six before- and after-school programs emphasize civic engagement, empathy, and making a difference in our communities.

Informed and active young citizens transmit a powerful signal: Fresh perspectives, holding leaders accountable, and creating a more inclusive society sustain and expand our democracy. Civic Nebraska invests in youth civic education and engagement across the state as a moral imperative and a strategic necessity. And we do it well.

Our six school-based Community Learning Centers – before- and after-school programs with civic education embedded into students' daily activities – empower the next generation of leaders to find their voice and learn how to make an impact in their communities. Combining traditional outside-of-school spaces with pro-democracy programming provides students multiple entry points to participate with purpose. In the past year:

Students at three Community Learning Centers established community gardens to beautify their schools and neighborhoods, provide healthy food alternatives to families in local food deserts, and promote cross-cultural understanding. Our Omaha-based CLCs collaborated weekly on *Civic Buddies*, in which middle-schoolers at Lewis & Clark Middle School read civics- and citizenship-related childrens' books to their counterparts at Sherman and Lothrop elementaries via Zoom. Thanks to generous sponsors, the younger children could keep their books to enjoy over and over.

We tied the prosocial aspects of democracy to academic success by equipping young people with the tools to navigate our socially, emotionally, and political complex world. We integrated those tools into each student's academic journey, resulting in well-rounded, responsible, empathetic youth who create meaningful change.

Youth civic leadership is imperative to democracy.

That's why we start early, empowering Nebraska youth to lead the positive progress they seek in their world, and normalizing civic engagement at an early age.



ON THE MIC

There is such power in student voice. The various clubs, programs, and other opportunities we offer are always stronger when students either come up with the idea or have a strong voice in imagining what the outcomes will be.

This is a powerful responsibility, and the benefits

are endless. Our school-based Community Learning Centers co-create the future with young people and show them how to shape a better world by getting involved. Students get to explore new ideas outside of the traditional classroom, and this is what a more modern and robust democracy is all about.

Our community is not just made up of the students

we serve. Schools are hubs of thriving communities – families, neighbors, local businesses and nonprofits, and so many others. We are always looking to engage the community beyond students after school. Our CLCs host community cafes, convene family and culture nights, and lead our School Neighborhood Advisory Committees, among many other things.

We focus on bringing people together and creating space for collaboration. It's our job to provide a safe place for students to go after school for quality programs that enrich their educational experience.

Students were uniquely affected by the pandemic.

We're finding new, creative, and nimble ways to adapt and meet students where they are at. It's challenging work, but so very satisfying.

Civic Nebraska started as encore for Kent Day. It became a lot more.

After 30 years in the classroom, our

founding director of youth civic leadership – who retired March 1, 2023 – was my first full-time hire in 2012. Kent created, then built up our Youth Civic Leadership program, which now serves hundreds of students around Nebraska. Under Kent's guidance, Civic Nebraska's before- and afterschool programs grew steadily, scored highly in student, teacher, and parent satisfaction, and encouraged students in our Community Learning Centers to become community leaders. We salute Kent for all that he's done for Civic Nebraska and the families we serve. Kent's kindness, creativity, and dedication continues to be felt – something we hope never ends. — Adam Morfeld



WHAT'S NEXT FOR CIVIC NEBRASKA THE NEXT WAVE



IN 2024, OUR VOTING RIGHTS INTIATIVES WILL ...

Lead the push at the State Capitol to end Nebraska's **arbitrary two-year waiting period** for voters who have fully paid their debts to society following felony convictions.

Educate and assist Nebraska voters in navigating the state's new **voter ID** law.

Recruit, train, and deploy dozens of Election Protectors to conduct **nonpartisan election observation** at polling places around the state.

Knock thousands of doors to **register voters for the 2024 primary and general elections**, and ensure there are as few barriers to the ballot as possible.

OUR CIVIC HEALTH PROGRAMS WILL ...

Distribute funds in partnership with the Community Builder Coalition through the **Strong Neighborhoods Grants** program to support neighborhood projects and professional development opportunities for neighbors.

Share education and resident leadership skill-building/

skill-sharing through a **Renter's Rights** guide and **Democracy Cohorts** in rural Nebraska.

Expand **Capitol Experience Days** with Nebraska youth and community groups who have irregular access to our State Capitol and government.

Develop a **civic health self-assessment tool** for individuals and groups to identify their current level of civic health, plus resources for areas of improvement.

Solidify relationships with the communities each of our school-based **Community Learning Centers** serves through family events, collaboration, skill-sharing, and other intiatives.

Use the 2024 elections as real-time ways to **study and understand the issues** before us, the voting process, and the roles and habits of active, responsible citizens.


■ Increase **civics-aligned programming opportunities** so students master the skills to navigate – and thrive in – their worlds.


